Municipal Ordinance No. 01

Municipal Ordinance No. 02            An Ordinance approving the Municipal Development Council (MDC) Resolution Number 05 and 06 Series of 2010.

Municipal Ordinance No. 03            An Ordinance abolishing the portion of Administrative Aid IV (Item-V, SG-4) in the Office of Municipal Accountant.

Municipal Ordinance No. 04            An Ordinance creating an Administrative Aid III (Item-V, SG-3) in the Office of the Municipal Accountant.

Municipal Ordinance No. 05            An Ordinance approving the Development Permit of the Proposed Angel of God memorial Garden located at Sitio Telagunting Valdez, Floridablanca, Pampanga.

Municipal Ordinance No. 06            An Ordinance creating the position of Veterinarian I with Salary grade 13 under the Office of the Economic Enterprise.

Municipal Ordinance No. 07            An Ordinance designating and establishing a Central Terminal for Public Utility Jeepneys (PUJ's) at the Kasudlong Public Market in the Municipality of Floridablanca and for the other purposes.

Municipal Ordinance No. 08            Ordinance reclassifying the property of Big Mountain Land and Housing Development Corp. situated at Carmen-Valdez, Floridablanca, Pampanga with an area of 23,645 square meters registered in the name of Roy D. Flora under TCT No. 042-2010012232, from Agricultural to Residential.

Municipal Ordinance No. 09            An Ordinance realignment of Fund in the Sangguniang Bayan Office.

Municipal Ordinance No. 10            Ordinance abolishing the Clerk III Position in the Office of the Municipal Civil Registrar.

Municipal Ordinance No. 11            An Ordinance creating the position of the Data Encoder I with Salary Grade 6 in the Office of the Municipal Civil Registrar.

- Municipal Ordinance No. 12                      An Ordinance prohibiting the use, sale, distribution and advertisement of cigarettes and other tobacco products in certain places, imposing penalties for violators thereof and providing funds therefor, and for other purposes. (Deferred)
- Municipal Ordinance No. 13                      An Ordinance to curtail the sale, rental transfer, distributor, manufacture and/or production of pirated counterfeit or fake goods, articles or services and for other services, and for other purposes. (Deferred)
- Municipal Ordinance No. 14                      An Ordinance approving the 2011 Supplemental Budget of The 20% additional BIR Allotment- Intended for Development Projects within the Municipality of Floridablanca, Pampanga in the amount P1,854,779.00
- Municipal Ordinance No. 15                      An Ordinance approving the 20% BIR allotment intended for Development Projects of the Municipality of Floridablanca, Pampanga for Budget Year 2012 amounting to Twenty Three Million Forty Four Thousand Two Hundred Seventy Three Pesos Only. (P23,044,273.00)
- Municipal Ordinance No. 16                      An Ordinance approving the application for Preliminary Approval and Location Clearance (PALC) of the proposed Commercial/Residential La Consolacion Avenue on the properties of Mr. Marlon L. Coronel embraced by TCT No. 389161-R located at Brgy. Poblacion, Floridablanca, Pampanga with an Area of 1,735 Square Meters.
- Municipal Ordinance No. 17                      An ordinance approving the Development Permit of the proposed Commercial, Residential La Consolacion Avenue on the properties of Mr. Marlon L. Coronel embraced by TCT Number 38961-R located at barangay Poblacion, Floridablanca, Pampanga with an area of 1,735 Square Meters.
- Municipal Ordinance No. 18                      An Ordinance creating the position of Market Supervisor III with Salary Grade 18 under the Economic Enterprise effective upon approval.
- Municipal Ordinance No. 19                      An Ordinance Realignment of fund in the Office of the Vice-Mayor and Sangguniang Bayan Office, Floridablanca, Pampanga.

- Municipal Ordinance No. 20 An Ordinance appropriating the General Fund Budget of the Municipal Government of Floridablanca, Pampanga for Calendar Year 2012 with a total amount of One Hundred Thirty Two Million Fifty Eight Thousand Nine Hundred Twenty Two Thousand 64/100 Pesos (Php 132,058,922.64) and operation of Economic Enterprises with a total amount of Fourteen Million Three Hundred Sixty Two Thousand Five Hundred Twenty Four 32/100 Pesos (Php 14,363,524.32).
- Municipal Ordinance No. 21 An Ordinance stating that the land use of the site of Floridablanca Resettlement Project falls within the areas zoned for residential purposes and that all lots consists of 3,643 lots capacity intended for housing construction of the Beneficiaries/Awardees of Floridablanca Resettlement Project which are now subject to mass residential application for issuance of individual miscellaneous sales patents as titles of their respective awards are not needed for public use or purpose of the Municipal Government of Floridablanca, Pampanga.
- Municipal Ordinance No. 22 An Ordinance adopting a program on Child Abuse prevention and Intervention and the formation of the Child Abuse Prevention and Intervention Network (CAPIN) under the Municipal Council for the protection of children. (Deferred)
- Municipal Ordinance No. 23 An Ordinance approving the Supplemental Budget Number 1 in the amount of (P11,838,637.79)
- Municipal Ordinance No. 24 An Ordinance approving the realignment of fund in the 20% Municipal Development Fund for 2011 in the total amount of Seven Million Eight Hundred Thirty Nine Thousand Seven Hundred Twenty Three and Eighty 80/100 (P7,839,723.80).
- Municipal Ordinance No. 25 An Ordinance Approving the Realligment of Fund in the Gender and Development Fund (5%) Program.
