WHEREAS, the Municipality of Floridablanca through the MDRRM Office requested the Purchase of Thirty Six (36) Bottles Alkyl Dimethylbenzyl Ammonium Chloride chemical solution to be used for Coronavirus Disease (COVID-19) Vaccination with PR No. 300-21-03-002 with an estimated cost of ONE HUNDRED SIXTY FIVE THOUSAND SIX HUNDRED PESOS (Php. 165,600.00) dated March 1, 2021.




Whereas, the conduct of Negotiated Procurement-Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement is proper and justified;


