BAC Resolution No. 20-04-441 – Negotiated Procurement-Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement for the Purchase of Assorted Goods to be given to the Indigent Residence in the Municipality of Floridablanca as per under the Proclamation of State of Calamity in Pampanga

WHEREAS, the Municipality of Floridablanca through the MSWD Office requested the Purchase of Assorted Goods to be given to the Indigent Residence in the Municipality of Floridablanca as per under the Proclamation of State of Calamity in Pampanga with PR No. 100-20-03-748 with an estimated cost of TWO MILLION SIXTY SEVEN THOUSAND SEVEN HUNDRED FIFTY FIVE PESOS (Php 2,067,755.00) dated March 16, 2020.

WHEREAS, the BAC recommended for the conduct of Negotiated Procurement - Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement for the Purchase of Assorted Goods to be given to the Indigent Residence in the Municipality of Floridablanca as per under the Proclamation of State of Calamity in Pampanga wherein which its fund shall be taken from the Calamity/LDRRM Fund with an Approved Budget of Seventeen Million Nine Hundred Ninety Four Thousand One Hundred Forty Seven Pesos and Forty Five Centavos (17,994,147.45);

WHEREAS, Section 53.2 of the revised IRR of RA 9184, otherwise known as the Government Procurement Act, allows the resort to Negotiated Procurement-Emergency Cases subject to condition required by law;

Whereas, the BAC sees it proper to conduct Negotiated Procurement-Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement for the Purchase of Assorted Goods to be given to the Indigent Residence in the Municipality of Floridablanca as per under the Proclamation of State of Calamity in Pampanga ;

Whereas, the conduct of Negotiated Procurement-Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement is proper and justified;


Whereas, the BAC found the offer of M.G. SERRANO ENTERPRISE as responsive and in accordance with the preference of the End-User;


NOW, THEREFORE, WE, the members of the BAC, hereby RESOLVE as it is hereby RESOLVED to recommend to the Head of the Procuring Entity for the Purchase of Assorted Goods to be given to the Indigent Residence in the Municipality of Floridablanca as per under the Proclamation of State of Calamity in Pampanga with the total amount of TWO MILLION SIXTY FOUR THOUSAND FIFTY PESOS (Php 2,064,050.00) to be awarded and procured from M.G. SERRANO ENTERPRISE.
