WHEREAS, the Municipality of Floridablanca through the MSWD Office requested the Purchase of Seven Hundred Forty (740) Trays of Eggs to be given to Families under Home Quarantine from Different Barangays in this Municipality with PR No. 100-21-10-3226 with an estimated cost of ONE HUNDRED EIGHTY FIVE THOUSAND PESOS (Php. 185,000.00) dated September 27, 2021.

WHEREAS, the BAC recommended for the conduct of Emergency Procurement under Republic Act No. 11469 or the Bayanihan to Heal as One Act as an Alternative Mode of Procurement for the Purchase of Seven Hundred Forty (740) Trays of Eggs to be given to Families under Home Quarantine from Different Barangays in this Municipality wherein which its fund shall be taken from the Calamity/LDRRM Fund;

NOW, THEREFORE, WE, the members of the BAC, hereby RESOLVE as it is hereby RESOLVED to recommend to the Head of the Procuring Entity for the Purchase of Seven Hundred Forty (740) Trays of Eggs to be given to Families under Home Quarantine from Different Barangays in this Municipality with the total amount of ONE HUNDRED SEVENTY SEVEN THOUSAND SIX HUNDRED PESOS (Php. 177,600.00) to be awarded and procured from JM JAY STORE.
