**BAC Resolution No. 20-04-460 – Negotiated Procurement-Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement for the Purchase of Sixty (60) Cavans 50KG of Rice and Nine Hundred Eleven (911) 25KG Sacks of Rice to be used for the Relief Operations of this Municipality**

WHEREAS, the Municipality of Floridablanca through the MSWD Office requested the Purchase of Sixty (60) Cavans 50KG of Rice and Nine Hundred Eleven (911) 25KG Sacks of Rice to be used for the Relief Operations of this Municipality with PR No. 100-20-04-835 with an estimated cost of ONE MILLION TWO HUNDRED THIRTY FOUR THOUSAND TWO HUNDRED PESOS (Php 1,234,200.00) dated April 2, 2020.

WHEREAS, the BAC recommended for the conduct of Negotiated Procurement - Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement for the the Purchase of Sixty (60) Cavans 50KG of Rice and Nine Hundred Eleven (911) 25KG Sacks of Rice to be used for the Relief Operations of this Municipality wherein which its fund shall be taken from the Calamity/LDRRM Fund with an Approved Budget of Seventeen Million Nine Hundred Ninety Four Thousand One Hundred Forty Seven Pesos and Forty Five Centavos (17,994,147.45);

WHEREAS, Section 53.2 of the revised IRR of RA 9184, otherwise known as the Government Procurement Act, allows the resort to Negotiated Procurement-Emergency Cases subject to condition required by law;


Whereas, the BAC sees it proper to conduct Negotiated Procurement-Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement for the Purchase of Sixty (60) Cavans 50KG of Rice and Nine Hundred Eleven (911) 25KG Sacks of Rice to be used for the Relief Operations of this Municipality;

Whereas, the conduct of Negotiated Procurement-Emergency Cases (Sec. 53.2) as an Alternative Mode of Procurement is proper and justified;


