BAC Resolution No. 2022-11-87 Recommending the use of Negotiated Procurement – Lease of Real Property and Venue for the Procurement of Food, Venue and Accommodation for the Lakbay-Aral and Seminar on Anti-Discrimination and Gender Based Violence: A Doorstep to Eliminate Discriminatory Practices in the Workplace on December 6-7, 2022

WHEREAS, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the procuring entity abides by the standard set forth by the said Act;

WHEREAS, Section 10 Rule IV of the IRR-A of RA 9184 provides that all procurement shall be done through competitive bidding, except as provided for in Article XVI of this Act;

WHEREAS, Rule XVI, Section 53.10 allowed the use of Negotiated Procurement – Lease of Real Property and Venue as alternative mode of procurement, with preference over the publicly-owned real property or venue from other government agencies;

WHEREAS, per Annex H of the Revised IRR of RA 9184 “in the event that the Procuring Entity would resort to privately-owned real property or venue, the End-User unit shall justify that the same is more efficient and economical to the government;”

WHEREAS, the Bids and Awards Committee (BAC) of the Municipality of Floridablanca through the MSWD Office requested for the Procurement of Food, Venue and Accommodation for the Lakbay-Aral and Seminar on Anti-Discrimination and Gender Based Violence: A Doorstep to Eliminate Discriminatory Practices in the Workplace on December 6-7, 2022 with PR No.100-22-11-4354 dated November 14, 2022 with an Approved Budget for the Contract amounting to Two Hundred Fifty Three Thousand Pesos (P253,000.00).

WHEREAS, the Bids and Awards Committee (BAC) through the Procurement Office sent the Request for Quotation on November 23, 2022 to three (3) venues within the vicinity of the selected location namely: (a) BY THE SEA RESORT HOTEL, (b) SUZUKI BEACH RESORT, and (c) CENTRAL PARK REEF RESORT;

WHEREAS, on November 28, 2022, the Bids and Awards Committee (BAC) with the assistance of the Technical Working Group (TWG) opened the sole sealed quotation and upon evaluation resulted in the hereunder findings:


