**INVITATION TO BID FOR THE CONSTRUCTION OF VARIOUS FACILITIES AT SAN PEDRO
ECO PARK, BARANGAY SAN PEDRO, FLORIDABLANCA, PAMPANGA (ITB No. 20-07-16)**

The **Municipality of Floridablanca** through the **20% Development Fund 2020** intends to apply the sum of **TEN MILLION PESOS (P 10,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **CONSTRUCTION OF VARIOUS FACILITIES AT SAN PEDRO ECO PARK, BARANGAY SAN PEDRO, FLORIDABLANCA, PAMPANGA**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Floridablanca now invites bids for the **CONSTRUCTION OF VARIOUS FACILITIES AT SAN PEDRO ECO PARK, BARANGAY SAN PEDRO, FLORIDABLANCA, PAMPANGA**. Completion of works is required within One Hundred Twenty (120) Calendar Days. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Municipality of Floridablanca and inspect the bidding documents at the address given below from 8:00 A.M. until 5:00 pm.

A complete set of bidding documents may be purchased by interested bidders from the address below starting on **July 29, 2020 until bid opening on August 18, 2020 2:00 pm** and upon payment of a non-refundable fee for the bidding documents in the amount of **Ten Thousand Pesos P 10,000.00**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Municipality of Floridablanca, provided that bidders shall pay the fee for the bidding documents not later than the submission of the bids.

The Municipality of Floridablanca will hold a Pre-bid conference on **August 6, 2020 at 2:00 p.m.** at the Municipal Conference Hall 2nd Floor, Municipality of Floridablanca, Pampanga which shall be open to all interested parties.

Bids must be duly received by the BAC Secretariat at the address below on or before **August 18, 2020 at 2:00 p.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated at ITB Clause 18.

Bid opening shall be on **August 18, 2020 at 2:00 p.m.** at the Municipal Conference Hall 2nd Floor, Municipality of Floridablanca, Pampanga. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The BAC Committee of the Municipality of Floridablanca reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
