

**INVITATION TO BID FOR THE PURCHASE OF ASSORTED ITEMS TO BE USED FOR
STOCKPILE IN THE MSWD OFFICE IN THIS MUNICIPALITY**

The **Municipality of Floridablanca** through the 5% Calamity Fund intends to apply the sum of **FOUR HUNDRED FORTY NINE THOUSAND NINE HUNDRED NINETY NINE PESOS AND 95/100 (P 449,999.95)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **PURCHASE OF ASSORTED ITEMS TO BE USED FOR STOCKPILE IN THE MSWD OFFICE IN THIS MUNICIPALITY**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Floridablanca now invites bids for the **PURCHASE OF ASSORTED ITEMS TO BE USED FOR STOCKPILE IN THE MSWD OFFICE IN THIS MUNICIPALITY**. Completion of works is required within (15) fifteen calendar days. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is open to all interested local bidders, subject to the conditions for eligibility provided in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from Municipality of Floridablanca and inspect the bidding documents at the address given below from 8:00 A.M. until 5:00 pm.

A complete set of bidding documents may be purchased by interested bidders from the address below starting on December 27, 2018 and upon payment of a non-refundable fee for the bidding documents and it may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Municipality of Floridablanca, provided that bidders shall pay the fee for the bidding documents not later than the submission of the bids.


The Municipality of Floridablanca will hold a Pre-bid conference on January 8, 2019 at 2:00 p.m., which shall be open to all interested parties.

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The BAC Committee of the Municipality of Floridablanca reserves the right to accept or reject any bid to annul the bidding process and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
