

**INVITATION TO BID FOR THE PURCHASE OF TWO UNITS PICK-UP TO BE USED
DURING EMERGENCIES AND RESCUE OPERATIONS**

The **Municipality of Floridablanca** through the Performance Challenge Fund of the Department of Interior and Local Government intends to apply the sum of **THREE MILLION PESOS (P 3,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **PURCHASE OF TWO (2) UNITS PICK-UP TO BE USED DURING EMERGENCIES AND RESCUE OPERATIONS IN THIS MUNICIPALITY**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Floridablanca now invites bids for the **PURCHASE OF TWO UNITS PICK-UP TO BE USED IN THIS MUNICIPALITY**. Completion of works is required within (30) thirty calendar days. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is open to all interested local bidders, subject to the conditions for eligibility provided in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from Municipality of Florida Blanca and inspect the bidding documents at the address given below from 8:00 A.M. until 5:00 pm.

A complete set of bidding documents may be purchased by interested bidders from the address below starting on December 14, 2017 and upon payment of a non-refundable fee for the bidding documents and it may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Municipality of Floridablanca, provided that bidders shall pay the fee for the bidding documents not later than the submission of the bids.

The Municipality of Floridablanca will hold a Pre-bid conference on December 22, 2017 at 2:00 p.m., which shall be open to all interested parties.


Bids must be delivered to the address below on or before January 3, 2017 at the BAC Secretariat, Municipality of Floridablanca at Floridablanca, Pampanga. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated at ITB Clause 18.

Bids will be opened in the presence of the bidders representatives who choose to attend at the address below. Late bids shall not be accepted.

The BAC Committee of the Municipality of Floridablanca reserves the right to accept or reject any bid to annul the bidding process and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
